  - 4. Graduation Marksheet (for appearing candidate upload latest mark sheet containing percentage obtained till now)
  - 5. PG degree/Diploma Marksheet (if any) (for appearing candidate upload latest mark sheet)
  - 6. Experience Certificate (if any)
  - 7. Category certificate as applicable
  - 8. Undertaking for submitting category certificate EWS/OBC candidates only (Duly signed by the candidate in the format attached in email)

- Institute reserves the right not to allow candidates reporting after 30 minutes from the reporting time to appear in the online process. Make sure you report well in time. The candidate will receive a link for the online process and its schedule in advance.
- It is mandatory for candidates whose result is yet to be declared or who are appearing in their final semester/year examination of qualifying degree to submit a certificate, signed by competent authority, from their institute in the prescribed format (Annexure 2/Annexure 3 in Admission information Brochure). Suppose any candidate is unable to produce a certificate to this effect. In that case, they will have to submit an undertaking stating that they will submit the certificate at the time of registration for the program if selected.
- Candidates applied under EWS and OBC category should submit an undertaking through Google form stating that Category Certificate shall be submitted on or before April 15, 2025. The caste certificates for OBC and EWS category should be issued by the competent authority (as per the format given in the information brochure) on or after APRIL 1, 2025. Failure to do so will result in cancellation of admission in applied category.
